A SUPPLEMENT

To the act of November 30, 1965 (P.L.843, No.355), entitled "An 1 act providing for the establishment and operation of Temple 2 University as an instrumentality of the Commonwealth to serve 3 as a State-related university in the higher education system 4 of the Commonwealth; providing for change of name; providing 5 for the composition of the board of trustees; terms of 6 7 trustees, and the power and duties of such trustees; providing for preference to Pennsylvania residents in 8 9 tuition; providing for public support and capital 10 improvements; authorizing appropriations in amounts to be fixed annually by the General Assembly; providing for the 11 auditing of accounts of expenditures from said 12 13 appropriations; authorizing the issuance of bonds exempt from taxation within the Commonwealth; requiring the President to 14 make an annual report of the operations of Temple 15 University," making an appropriation for carrying the same into effect; providing for a basis for payments of such 16 17 appropriation; and providing a method of accounting for the 18 19 funds appropriated and for certain fiscal information disclosure. 20 The General Assembly of the Commonwealth of Pennsylvania

- 22 hereby enacts as follows:
- 23 Section 1. The following sum, or as much thereof as may be
- 24 necessary, is hereby appropriated to the Trustees of Temple
- 25 University for the fiscal year July 1, 2018, to June 30, 2019,
- 26 for the purposes and in the amount as shown:
- 27 For general support..... \$150,586,000
- 28 Section 2. Payments to Temple University on account of the

- 1 appropriation provided in section 1 shall be made on the basis
- 2 of costs during the fiscal year.
- 3 Section 3. (a) Payment to Temple University of the
- 4 appropriation provided in section 1 shall be made monthly during
- 5 the fiscal year.
- 6 (b) Such monthly payments shall be made in accordance with
- 7 the provisions of section 2 on the basis of estimated costs. The
- 8 estimate of costs shall be submitted by Temple University to the
- 9 Secretary of Education, the General Assembly and the State
- 10 Treasurer not later than 30 days prior to the date on which such
- 11 payment is to be made.
- 12 Section 4. (a) Temple University shall apply the moneys
- 13 appropriated by this act only for such purposes as are permitted
- 14 in this act and shall at all times maintain proper records
- 15 showing the application of such moneys. Not later than 120 days
- 16 after the close of the fiscal year to which this act relates,
- 17 Temple University shall file, with the Secretary of Education,
- 18 the General Assembly and the Auditor General of the
- 19 Commonwealth, a statement setting forth the amounts and purposes
- 20 of all expenditures made from moneys appropriated by this act
- 21 and other university accounts during said fiscal year, as
- 22 provided in section 2, used as a basis for receipt of any
- 23 appropriation during said fiscal year.
- 24 (b) Such statement of expenditures and costs shall be
- 25 reviewed by the Auditor General of the Commonwealth, and he
- 26 shall have the right, in respect to the moneys appropriated by
- 27 this act, to audit and disallow expenditures made for purposes
- 28 not permitted by this act and to cause such sums to be recovered
- 29 and paid by Temple University to the State Treasurer. In respect
- 30 to expenditures made by the university from moneys other than

- 1 those appropriated by this act, the Auditor General shall have
- 2 the right to review only, and he shall file annually with the
- 3 General Assembly such information concerning said expenditures
- 4 as the General Assembly or any of its committees may require.
- 5 Section 5. Temple University shall provide full, complete
- 6 and accurate information as may be required by the Department of
- 7 Education or the chairman or the minority chairman of the
- 8 Appropriations Committee of the Senate or the chairman or the
- 9 minority chairman of the Appropriations Committee of the House
- 10 of Representatives.
- 11 Section 6. Temple University shall present and report its
- 12 financial statements required under the provisions of this act
- 13 in accordance with: the generally accepted accounting principles
- 14 as prescribed by the National Association of College and
- 15 University Business Officers, the American Institute of
- 16 Certified Public Accountants, or their successors, or by any
- 17 other recognized authoritative body; the "Commonwealth of
- 18 Pennsylvania Budget Instructions for the State System of Higher
- 19 Education, State-Related Universities and Non-State-Related
- 20 Colleges and Universities"; and the financial reporting policies
- 21 and standards promulgated by the Commonwealth of Pennsylvania
- 22 and by the Federal Government that apply to Temple University.
- 23 Section 7. This act shall take effect July 1, 2018, or
- 24 immediately, whichever is later.
