SUMMARY: This bill would amend Title 4 (Amusements), Title 18 (Crimes and Offenses), Title 23 (Domestic Relations), Title 27 (Environmental Resources) and Title 75 (Vehicles) eliminating the suspension of driver's license as a penalty for several non-highway violations.

ANALYSIS: House Bill 42 would remove penalties involving driver's license suspensions for the following non-highway violations:

- Title 4 Pa.C.S. § 1518(b)(4) (related to the purchase, consumption, possession or transportation of liquor or malt or brewed beverages) in a licensed gaming facility.
- Title 18 Pa.C.S. § 3929(b)(1.1)(iii) (related to retail theft of motor fuel in addition to merchandise less than \$150) for the third and subsequent offense.
- Title 18 Pa.C.S. § 6305 (b)(3)(iv) (related to the sale of tobacco to a minor)
- Title 18 Pa.C.S. § 6307(b) (related to the misrepresentation of age to secure liquor or malt or brewed beverages)
- Title 18 Pa.C.S. § 6308 (b) (related to the purchase, consumption, possession or transportation of liquor or malt or brewed beverages)
- Title 18 Pa.C.S. § 6310.3(b) (related to carrying a false identification card)
- Title 23 Pa.C.S. § 4355(d.1) (related to special procedures for operating privilege)
- Title 27 Pa.C.S. § 6208(a) (related to penalties involving waste transportation safety)
- Title 75 Pa.C.S. § 1532(a)(1) (related to the suspension of operating privilege for felony convictions, which the court determines vehicle involvement)
- Title 75 Pa.C.S. § 1532(c) (related to the suspension of operating privilege for offenses involving a controlled substances)
- Title 18 Pa.C.S. § 2706 (related to the crime of terroristic threats)

Language restricting the operating privilege under Title 18 Pa.C.S. § 6310.4 (related to the restriction of operating privileges) would be repealed.

This act would be effective 60 days upon passage.

FISCAL IMPACT: The Department of Transportation (DOT) would experience \$160,480 in annual personnel savings, as DOT staff would no longer be required to process driver's license

suspensions for the crimes and offenses enumerated under this act. DOT would also experience \$980,000 in annual revenue losses. During the 2016 calendar year (CY), DOT processed approximately 14,000 violations of the kind described under this act. Each violator was required to pay a non-commercial restoration fee of \$70.00. When multiplying this restoration fee by the number of violators in CY 2016, the estimated amount of revenue losses would be \$980,000. Additionally, DOT would incur a one-time cost of \$100,000 to conduct changes to its Driver License and Control system to reflect the changes in restoration fees, as defined under this act.
