**SUMMARY:** This legislation amends the Independent Oversight and Review of Regulations Act, further providing for definitions and for existing regulations; and establishing the Independent Office of the Repealer and providing for powers and duties.

**ANALYSIS:** This legislation would establish a nonpartisan Independent Office of the Repealer (OOTR) as an independent agency. The duties of the office shall include reviewing existing regulations and statutes to identify those that may be appropriate for modification, revision or repeal. Additionally, this legislation will require the OOTR to establish a system with a publicly accessible internet website to receive suggestions and comments from the public, businesses and government agencies. Under this legislation, the OOTR will be required to report recommended changes to statutes and regulations, recommended changes to increase efficiency and wasteful practices and progress of the revision and repeal of statutes and regulations to the General Assembly and the Governor on or before June 30<sup>th</sup> of each year.

The selection committee created within the OOTR shall include: one member appointed by the Governor, one member appointed by the President Pro Tempore of the Senate in consultation with the majority and minority leaders of the Senate, and one member appointed by the Speaker of the House of Representatives in consultation with the majority and minority leaders of the House of Representatives.

This act shall take effect immediately and shall expire on June 30, 2024.
