The Commonwealth received \$3,935,170,000.00 through Title V of the CARES Act. Those monies were deposited into the federal COVID-Relief Fund account (Account 87710). Act 24 of 2020 specifies that the funds received are restricted and shall be appropriated. The account will now be designated as COVID-Relief Fund Restricted.
