

AN ACT

1 Providing for the capital budget for fiscal year 2019-2020;
2 itemizing public improvement projects, furniture and
3 equipment projects and redevelopment assistance projects
4 leased or assisted by the Department of General Services and
5 other State agencies, together with their estimated financial
6 costs; authorizing the incurring of debt without the approval
7 of the electors for the purpose of financing the projects to
8 be constructed, acquired or assisted by the Department of
9 General Services and other State agencies; authorizing the
10 use of current revenue for the purpose of financing the
11 projects to be constructed, acquired or assisted by the
12 Department of General Services and other State agencies
13 stating the estimated useful life of the projects; and making
14 appropriations.

15 The General Assembly of the Commonwealth of Pennsylvania
16 hereby enacts as follows:

17 Section 1. Short title.

18 This act shall be known and may be cited as the Capital
19 Budget Project Itemization Act of 2019-2020.

20 Section 2. Total authorizations.

21 (a) Public improvements.--The total authorization for the
22 additional capital projects in the category of public
23 improvement projects itemized in section 3 and to be acquired or

1 constructed by the Department of General Services, its
2 successors or assigns, and to be financed by the incurring of
3 debt shall be \$6,866,548,000.

4 (b) Furniture and equipment.--The total authorization for
5 the additional capital projects in the category of public
6 improvement projects consisting of the acquisition of original
7 movable furniture and equipment to complete public improvement
8 projects itemized in section 4 and to be acquired by the
9 Department of General Services, its successors or assigns, and
10 to be financed by the incurring of debt shall be \$411,005,000.

11 (c) Manufacturing Fund.--The total authorization for the
12 capital projects in the category of public improvement projects
13 itemized in section 5 to be acquired or developed by the
14 Department of Corrections and to be financed by current revenues
15 of the Manufacturing Fund pursuant to executive authorization
16 shall be \$21,000,000.

17 (d) Redevelopment assistance.--The total authorization for
18 the capital projects in the category of redevelopment capital
19 projects itemized in section 6 for capital grants by the
20 Department of Community and Economic Development, its successors
21 or assigns and to be financed by the incurring of debt shall be
22 \$750,000,000.

23 Section 3. Itemization of public improvement capital projects.

24 Additional capital projects in the category of public
25 improvement projects to be acquired or constructed by the
26 Department of General Services, its successors or assigns, and
27 to be financed by the incurring of debt, are hereby itemized,
28 together with their respective estimated financial costs, as

15 from time to time in addition to any authorization heretofore or
16 hereafter enacted, on the credit of the Commonwealth, subject to
17 the limitations provided in the current capital budget, money
18 not exceeding in the aggregate the sum specified in section
19 2(a).

20 (b) Furniture and equipment.--The Governor, Auditor General
21 and State Treasurer are hereby authorized and directed to borrow
22 from time to time in addition to any authorization heretofore or
23 hereafter enacted on the credit of the Commonwealth, subject to
24 the limitations provided in the current capital budget, money
25 not exceeding in the aggregate the sum specified in section 2(b)
26 as may be found necessary to carry out the acquisition and
27 construction of the public improvement projects consisting of
28 the acquisition of original movable furniture and equipment
29 specifically itemized in the capital budget.

30 (c) Redevelopment assistance.--Subject to the limitations in

1 section 317(b) of the act of February 9, 1999 (P.L.1, No.1),
2 known as the Capital Facilities Debt Enabling Act, the Governor,
3 Auditor General and State Treasurer are hereby authorized and
4 directed to borrow from time to time in addition to any
5 authorization heretofore or hereafter enacted on the credit of
6 the Commonwealth, subject to the limitations provided in the
7 current capital budget, money not exceeding in the aggregate the
8 sum specified in section 2(d) as may be found necessary to carry
9 out the redevelopment assistance capital projects specifically
10 itemized in the capital budget.

11 Section 8. Issue of bonds.

12 The indebtedness authorized in this act shall be incurred
13 from time to time and shall be evidenced by one or more series
14 of general obligation bonds of the Commonwealth in such
15 aggregate principal amount for each series as the Governor, the
16 Auditor General and the State Treasurer shall determine, but the
17 latest stated maturity date shall not exceed the estimated
18 useful life of the projects being financed as stated in section
19 9.

20 Section 9. Estimated useful life and term of debt.

21 (a) Estimated useful life.--The General Assembly states that
22 the estimated useful life of the public improvement projects
23 itemized in this act is as follows:

24 (1) Public improvement projects, 30 years.

25 (2) Furniture and equipment, 10 years.

26 (b) Term of debt.--The maximum term of the debt authorized
27 to be incurred under this act is 30 years.

28 Section 10. Appropriations.

29 (a) Public improvements.--The net proceeds of the sale of
30 the obligations authorized in this act are hereby appropriated

1 from the Capital Facilities Fund to the Department of General
2 Services in the maximum amount specified in section 2(a) to be
3 used by it exclusively to defray the financial cost of the
4 public improvement projects specifically itemized in a capital
5 budget. After reserving or paying the expenses of the sale of
6 the obligation, the State Treasurer shall pay to the Department
7 of General Services the money as required and certified by it to
8 be legally due and payable.

9 (b) Furniture and equipment.--The net proceeds of the sale
10 of the obligations authorized in this act are hereby
11 appropriated from the Capital Facilities Fund to the Department
12 of General Services in the maximum amount specified in section
13 2(b) to be used by it exclusively to defray the financial cost
14 of the public improvement projects consisting of the acquisition
15 of original movable furniture and equipment specifically
16 itemized in a capital budget. After reserving or paying the
17 expenses of the sale of the obligation, the State Treasurer
18 shall pay to the Department of General Services the money as
19 required and certified by it to be legally due and payable.

20 (c) Redevelopment assistance.--The net proceeds of the sale
21 of the obligations authorized in this act are hereby
22 appropriated from the Capital Facilities Fund to the Department
23 of Community and Economic Development in the maximum amount
24 specified in section 2(d) to be used by it exclusively to defray
25 the financial cost of the redevelopment assistance capital
26 projects specifically itemized in a capital budget. After
27 reserving or paying the expenses of the sale of the obligation,
28 the State Treasurer shall pay to the Department of Community and
29 Economic Development the money as required and certified by it
30 to be legally due and payable.

1 Section 11. Federal funds.

2 (a) Projects itemized in this act.--All money received from
3 the Federal Government for the projects specifically itemized in
4 this act are also hereby appropriated for those projects.

5 (b) Projects not requiring itemization.--Department of
6 Military and Veterans Affairs construction projects which are
7 totally federally funded and to be administered by the
8 Department of General Services are hereby authorized.

9 Section 12. Editorial changes.

10 In editing and preparing this act for printing following the
11 final enactment, the Legislative Reference Bureau shall insert
12 or revise letters or numbers for projects where the letters or
13 numbers are missing or require revision. The Legislative
14 Reference Bureau shall also revise the total monetary amounts
15 for the total authorization, debt authorization, appropriations
16 and department totals as necessary to agree with the total
17 monetary amounts of the projects.

18 Section 13. Effective date.

19 This act shall take effect immediately.
