

## AN ACT

1 Providing for the capital budget for fiscal year 2018-2019;  
2 itemizing public improvement projects and furniture and  
3 equipment projects leased or assisted by the Department of  
4 General Services, the Department of Conservation and Natural  
5 Resources, the Department of Environmental Protection, the  
6 Department of Transportation or the Pennsylvania Fish and  
7 Boat Commission, together with their estimated financial  
8 costs; authorizing the incurring of debt without the approval  
9 of the electors for the purpose of financing the projects to  
10 be constructed, acquired or assisted by the Department of  
11 General Services, the Department of Environmental Protection,  
12 the Department of Transportation or the Pennsylvania Fish and  
13 Boat Commission; authorizing the use of current revenue for  
14 the purpose of financing the projects to be constructed,  
15 acquired or assisted by the Department of Conservation and  
16 Natural Resources or the Department of Transportation stating  
17 the estimated useful life of the projects; and making  
18 appropriations.

19 The General Assembly of the Commonwealth of Pennsylvania  
20 hereby enacts as follows:

21 Section 1. Short title.

22 This act shall be known and may be cited as the Capital  
23 Budget Project Itemization Act of 2018-2019.

24 Section 2. Total authorizations.

25 (a) Public improvements.--The total authorization for the

1 additional capital projects in the category of public  
2 improvement projects itemized in section 3 and to be acquired or  
3 constructed by the Department of General Services, its  
4 successors or assigns, and to be financed by the incurring of  
5 debt shall be \$1,608,338,000.

6 (b) Furniture and equipment.--The total authorization for  
7 the additional capital projects in the category of public  
8 improvement projects consisting of the acquisition of original  
9 movable furniture and equipment to complete public improvement  
10 projects itemized in section 4 and to be acquired by the  
11 Department of General Services, its successors or assigns, and  
12 to be financed by the incurring of debt shall be \$3,000,000.

13 Section 3. Itemization of public improvement capital projects.

14 Additional capital projects in the category of public  
15 improvement projects to be acquired or constructed by the  
16 Department of General Services, its successors or assigns, and  
17 to be financed by the incurring of debt, are hereby itemized,

24	State Treasurer are hereby authorized and directed to borrow	
25	from time to time in addition to any authorization heretofore or	
26	hereafter enacted, on the credit of the Commonwealth, subject to	
27	the limitations provided in the current capital budget, money	
28	not exceeding in the aggregate the sum specified in section	
29	2(a).	
30	(b) Furniture and equipment.--The Governor, Auditor General	

1 and State Treasurer are hereby authorized and directed to borrow  
2 from time to time in addition to any authorization heretofore or  
3 hereafter enacted on the credit of the Commonwealth, subject to  
4 the limitations provided in the current capital budget, money  
5 not exceeding in the aggregate the sum specified in section 2(b)  
6 as may be found necessary to carry out the acquisition and  
7 construction of the public improvement projects consisting of  
8 the acquisition of original movable furniture and equipment  
9 specifically itemized in the capital budget.

10 Section 17. Issue of bonds.

11 The indebtedness authorized in this act shall be incurred  
12 from time to time and shall be evidenced by one or more series  
13 of general obligation bonds of the Commonwealth in such  
14 aggregate principal amount for each series as the Governor, the  
15 Auditor General and the State Treasurer shall determine, but the  
16 latest stated maturity date shall not exceed the estimated  
17 useful life of the projects being financed as stated in section  
18 18.

19 Section 18. Estimated useful life and term of debt.

20 (a) Estimated useful life.--The General Assembly states that  
21 the estimated useful life of the public improvement projects  
22 itemized in this act is as follows:

23 (1) Public improvement projects, 30 years.

24 (2) Furniture and equipment, 10 years.

25 (b) Term of debt.--The maximum term of the debt authorized  
26 to be incurred under this act is 30 years.

27 Section 19. Appropriations.

28 (a) Public improvements.--The net proceeds of the sale of  
29 the obligations authorized in this act are hereby appropriated  
30 from the Capital Facilities Fund to the Department of General

1 Services in the maximum amount specified in section 2(a) to be  
2 used by it exclusively to defray the financial cost of the  
3 public improvement projects specifically itemized in a capital  
4 budget. After reserving or paying the expenses of the sale of  
5 the obligation, the State Treasurer shall pay to the Department  
6 of General Services the money as required and certified by it to  
7 be legally due and payable.

8 (b) Furniture and equipment.--The net proceeds of the sale  
9 of the obligations authorized in this act are hereby  
10 appropriated from the Capital Facilities Fund to the Department  
11 of General Services in the maximum amount specified in section  
12 2(b) to be used by it exclusively to defray the financial cost  
13 of the public improvement projects consisting of the acquisition  
14 of original movable furniture and equipment specifically  
15 itemized in a capital budget. After reserving or paying the  
16 expenses of the sale of the obligation, the State Treasurer  
17 shall pay to the Department of General Services the money as  
18 required and certified by it to be legally due and payable.

19 Section 20. Federal funds.

20 (a) Projects itemized in this act.--All money received from  
21 the Federal Government for the projects specifically itemized in  
22 this act are also hereby appropriated for those projects.

23 (b) Projects not requiring itemization.--Department of  
24 Military and Veterans Affairs construction projects which are  
25 totally federally funded and to be administered by the  
26 Department of General Services are hereby authorized.

27 Section 21. (Reserved).

28 Section 22. Editorial changes.

29 In editing and preparing this act for printing following the  
30 final enactment, the Legislative Reference Bureau shall insert

1 or revise letters or numbers for projects where the letters or  
2 numbers are missing or require revision. The Legislative  
3 Reference Bureau shall also revise the total monetary amounts  
4 for the total authorization, debt authorization, appropriations  
5 and department totals as necessary to agree with the total  
6 monetary amounts of the projects.

7 Section 23. Effective date.

8 This act shall take effect immediately.
