Act 71 of 2004 established the Compulsive and Problem Gambling Treatment Fund. Section 1509 (6) of the Act provides that all monies in the fund are to be expended for education, prevention and treatment of problems related to gambling addiction and the administration of the compulsive and problem gambling program.

The following restricted revenue account will be used by the Department of Drug and Alcohol Programs to account for transfers from the State Gaming Fund for a program of education, prevention and treatment of compulsive and problem gambling in accordance with the act.
